

DESCRIPTION:

Soundscreed – 4 is a specially formulated polymer modified sand and cement mix to be used as floor screed where high quality and water resistant properties are required. A singly layer can be laid a thickness of upto 40 mm. Ideally suitable for large establishment, Podium Parking, Factory, Hospitals, Rooms, Warehouse, Supermarkets, Airports etc. Also a suitable background required floor hardener such as a Soundfloor—HT.

Also a Substitute for Brick bat coba used to maintain slopes in Bathroom, Terrace etc.

It helps in expansion contraction act as cushion between finished surface (Tiles, Paver blocks and RCC Slab)

COMPOSITION:

Soundscreed – 4 is a blend of high quality Portland cement and graded Brown Silica Sand combined with chemical additives that Soundscreed – 4 provides durable hardworking, trouble free flooring, Can be finish fairly smooth. Ready to use carpets, PVC tiles etc.

MIXING:

Soundscreed – 4 can be mixed in a concrete mix in addition of water approximately 8 to 8.5 Ltrs for 50 kg.

APPLICATIONS:

Soundscreed – 4 should be laid to required thickness not exceeding 40 MM per layer. Minimum 24 Hrs should lapse between layers where more thickness is required. Soundscreed – 4 can be finished to a smooth surface using conventional mason tools. Or can be powder floated.



CONSUMPTION / COVERAGE:

3.43 kg per Sq. Ft. For 20 mm thick.

CURING:

Normal curing with water is essential by flooding the screed and keep submerged for minimum 7 days.

PACKING:

Soundscreed – 4 is packed with 50 kg HDPE bag with liner.



STORAGE:

Soundscreed – 4 can be stored under shaded dry condition for a period of 12 months.
